



EAMA RSP Hybrid Meeting Notes December 17, 2025

Welcome – EAMA RSP Chair **Chris Jewell** started the meeting at 9:02 a.m.

Chris welcomed new EAMA RSP member **MFG Solutions**.

Chris opened the floor for employers to share their recent accomplishments.

- **Hannah Belmont** shared **Westminster Tool** has been able to hire six new employees at their newly acquired company, Winthrop Tackle in Essex.

Employer Instant Poll – Manufacturing members were asked to choose up to 7 topics from a list of 15 potential roundtable/webinar choices that they would be “most likely to attend.” Topics related to their workforce topped the list (specifically employee development, workplace culture, employee retention strategies, attracting employees, wellness programs and mental health supports). Other top vote getters were manufacturing apprenticeships and AI for productivity.

Wild Card Topic - **Director Tony Benoit** asked the members to comment on the holiday-inspired Wild Card question: “Has business been naughty or nice in 2025? What would you like Santa to leave under your company tree?”

Mary Fitzgerald shared that **Acme Wire** had its **best year ever** and they are projecting a positive 2026. Mary would like a “young toolmaker” under their company tree. **Meredith Shay** commented that **InCord** had a stable year and wished for healthy employees under their tree. **Chris Jewell** shared that business for **Collins & Jewell** was “naughty” for the first half of the year but was “nice” for the remainder of the year. He hoped for zero safety incidents under their tree. **Dan Chaplin** said business at **Forge 41** was mainly nice and, under his tree, he would like a new CNC machine. **Dave Young** from **APCM Manufacturing** had a backlog of sales orders that will carry into the new year. **Ryan Stickle** shared that business for **KPG Machine** was flat but defense work is carrying them through the end of the year. **Jeff Dickey** said business for **The Lee Company** improved in the second half of the year with their medical and aerospace segments picking up. He would like lots of new staff under his tree, especially a set-up machinist.

Employer Spotlight – **Meredith Shay, InCord**

InCord, located in Colchester, is America’s leading producer of safety netting. They are a Certified ISO 9001 Quality Management System manufacturer and a certified Women-Owned Small Business (WOSB) by the U.S. Small Business Administration (SBA). Meredith and her sister have owned the company since 2020. They produce custom netting for a wide variety of applications including amusement, sporting, construction, lifting, material handling, maritime, and theatre. Meredith proudly touted the fact they have been voted a Hartford Courant Top Workplace for fifteen consecutive years.

Youth Manufacturing Pipeline Initiative (YMPI) – **David Allard, EWIB**

David shared that the EAMA Youth Pipeline Working Group toured Bacon Academy in Colchester’s YMPI program in November. Employers were able to observe students in various classes engaged in sheet metal, blueprints, drafting, engineering, and automotive coursework aligned with YMPI and industry standards.

Eastern Advanced Manufacturing Alliance – A Connecticut Regional Sector Partnership

Industry partners discussed opportunities to strengthen alignment through facility tours, school-employer liaisons, externships, and internships, with YMPI identified as the important bridge.

David also shared that **Bacon Academy YMPI Teacher, David Mason** received the prestigious national Milken Educator Award (including a \$25,000 honorarium) recognizing his leadership and innovative hands-on manufacturing instruction (welding, machining, CNC, and fabrication). He was the only Connecticut educator selected this school year and will join other awardees at a Washington, D.C., forum in June 2026.

The YMPI is in the midst of another busy year with 12 returning schools and 3 additional new schools for a total of 15 programs. The current focus is on scheduling half-day training workshops for each YMPI cohort at either of the community college training centers (Quinebaug Valley and Three Rivers).

Manufacturing Pipeline Initiative (MPI) – **Carol LaBelle, EWIB** shared that during the first six months of the program year (July – December 2025), the MPI conducted 31 classes and trained approximately 330 participants. Looking ahead at the schedule for the second half of the program year (January – June 2026), 57 classes are planned, potentially training 700 participants which would bring the total number of individuals trained this program year to over 1,000.

Michael Nogelo from **EWIB** also shared that Electric Boat is looking to hire 2,000 trades workers in CT in each of the next three years. EB secured \$3M to expand training capacity with infrastructure and new equipment at existing and new MPI training facilities. They are waiting to hear about a much-needed infusion of additional funding to meet industry demand. EWIB is constantly thinking about how all EAMA RSP employers can benefit from the MPI and recognizes the challenges of wage competition. He encouraged EAMA RSP employers to consider hiring MPI graduates.

Partner Corner – Anna Mumford – CONNSTEP and Eileen Candels – CCAT

Anna reminded the members that the final rule for CMMC 2.0 was released in November and that Cybersecurity capabilities will be built into defense contracts requiring companies to demonstrate CMMC compliance to be eligible to bid on and receive defense contract awards. Eileen shared the CCAT oversees funding to assist with Cybersecurity compliance through the Manufacturing Innovation Fund (MIF) which can provide up to \$35,000 in matching funds for compliance-related activities. Director's Report – Tony Benoit

Accenture/DECD developing strategy for CT-RI Model-Based Enterprise Tech Hub – Tony reported that the federal government is providing funding to states to develop Innovation Hubs. The CT Department of Economic & Community Development (DECD) has hired Accenture to develop a joint application between Connecticut and Rhode Island for the region to serve as a center for model-based engineering. RTX, the parent company of Pratt & Whitney, now requires model-based design to speed up design and production. He also noted that CCAT provides training on model-based design.

CMC 2026 Legislative Priorities – Tony reminded members that EAMA RSP is a member of the Connecticut Manufacturers' Collaborative (CMC). CMC has set its priorities for the 2026 legislative session as follows:

- Allow pass through entities to be eligible for R&D tax credits
- Provide additional options for small manufacturing businesses to provide affordable health insurance for employees
- Address rising energy costs for small businesses
- Better align high school graduation requirements and the school accountability index with business and industry demands
- Provide economic stability for manufacturers by continuing strong adherence to the state's fiscal guardrails
- Require more effective agency regulation reviews to eliminate and modify burdensome and costly employer mandates
